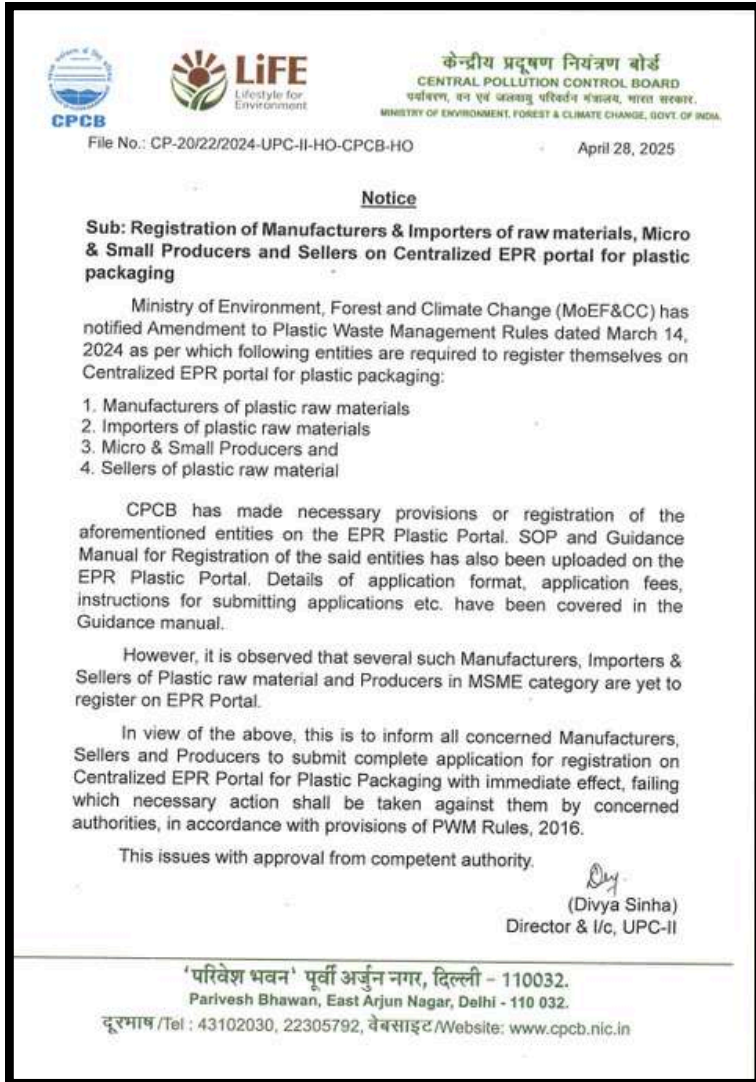

CPCB Issues notice regarding Registration of Manufacturers & Importers of raw materials, Micro & Small Producers and Sellers on Centralized EPR portal for plastic packaging



Ministry of Environment, Forest and Climate Change (MoEF&CC) has notified Amendment to Plastic Waste Management Rules dated March 14, 2024 as per which following entities are required to register themselves on Centralized EPR portal for plastic packaging:

1. Manufacturers of plastic raw materials
2. Importers of plastic raw materials
3. Micro & Small Producers and
4. Sellers of plastic raw material

CPCB has informed all concerned Manufacturers, Sellers and Producers to submit complete application for registration on Centralized EPR Portal for Plastic Packaging with immediate effect, failing which necessary action shall be taken against them by concerned authorities, in accordance with provisions of PWM Rules, 2016.

Sub: Registration of Manufacturers & Importers of raw materials, Micro & Small Producers and Sellers on Centralized EPR portal for plastic packaging

Ministry of Environment, Forest and Climate Change (MoEF&CC) has notified Amendment to Plastic Waste Management Rules dated March 14, 2024 as per which following entities are required to register themselves on Centralized EPR portal for plastic packaging:

1. Manufacturers of plastic raw materials
2. Importers of plastic raw materials
3. Micro & Small Producers and
4. Sellers of plastic raw material

CPCB has made necessary provisions or registration of the aforementioned entities on the EPR Plastic Portal. SOP and Guidance Manual for Registration of the said entities has also been uploaded on the EPR Plastic Portal. Details of application format, application fees, instructions for submitting applications etc. have been covered in the Guidance manual.

However, it is observed that several such Manufacturers, Importers & Sellers of Plastic raw material and Producers in MSME category are yet to register on EPR Portal.

In view of the above, this is to inform all concerned Manufacturers, Sellers and Producers to submit complete application for registration on Centralized EPR Portal for Plastic Packaging with immediate effect, failing which necessary action shall be taken against them by concerned authorities, in accordance with provisions of PWM Rules, 2016.
